Sub : Update on acquisition of 70% Equity Share Capital of EVER Electronics Private Limited
Ref: Disclosure pursuant to Regulation 30 of the SEBI (Listing Obligation and Disclosure Requirements) Regulations, 2015

This is in continuation to our letters dated 29th June 2018, 1st October 2018 and 29th December 2018 regarding acquisition of Ever Electronics Private Limited (“EVER”) to the extent of 70% stake of total Share Capital by the end of 31st March 2019 in one or more tranches.

Further, on 1st October 2018, EVER became the subsidiary of Amber Enterprises India Limited (“Amber”) and appointed majority of Directors on the Board of EVER.

We would like to inform you that Promoters of EVER has requested for extension of time limit for completing the Conditions Precedent to enable Amber to acquire balance 51% of stake of total Share Capital of EVER. The Company so far hold only 19% stake in the share capital of EVER.

Considering the request, Company has extended the timeline to complete the acquisition of balance stake of 51% by 30th June 2019 in one or more tranches.
