

Notes:

- 1 The above financial results were reviewed by the Audit Committee and taken on record by the Board of Directors in its meeting held on 24 May 2019. The statutory auditors have expressed an unmodified audit opinion on these results.
- 2 The above financial results have been prepared in accordance with the Indian Accounting Standards ('Ind AS') as notified under the Companies (Indian Accounting Standards) Rules, 2015 as amended by Companies (Indian Accounting Standard) Rules, 2016 as specified in section 133 of the Companies Act, 2013 and other recognised accounting practices to the extent applicable.
- Revenue from operations for the quarter and year ended 31 March 2019, quarter ended 31 March 2018, quarter ended 31 December 2018 and year ended 31 March 2018 is net of Goods and Service Tax (GST) which is applicable from 1 July 2017. However, revenue for the periods upto 30 June 2017 (included in figure of year ended 31 March 2018) was net of Value Added Tax (VAT) but inclusive of excise duty (applicable till 30 June 2017). Accordingly, the revenue from operations for the year ended 31 March 2019 are not strictly comparable with the year ended 31 March 2018 presented in those financial results. Similarly, excise duty expense is also not comparable.
- The Company's primary business segment is reflected based on principal business activities carried on by the Company. Chairman and Managing Director has been identified as being the Chief Operating Decision Maker ('CODM') and evaluates the Company's performance and allocates resources based on analysis of the various performance indicators of the Company as a single unit. Therefore, there are no separate reportable business segments as per Ind AS 108- Operating Segments. The Company operates in one reportable business segment i.e., consumer durable products and is primarily operating in India and hence, considered as single geographical segment.
- Figures for the quarter ended 31 March 2019 and 31 March 2018 as reported in these financial results are the balancing figures between audited figures in respect of full financial year and the published year to date figures upto the third quarter of the financial year. Also, the figures upto the end of the third quarter were only reviewed and not subjected to audit.
- Subsequent to the year ended 31 March 2019, the Company has made an investment for the acquisition of 36,000 equity shares of Sidwal Refrigeration Industries Private Limited ('Sidwal') on 2 May 2019 which represents 80% of the total paid up share capital of Sidwal. Sidwal is engaged in the business of manufacturing and sale of heating, ventilation, air conditioning and refrigeration equipment for mobile applications such as railway coaches, metro coaches, buses, telecom, commercial refrigeration and related components.
- 7 The figures for the corresponding previous period/year have been regrouped/ reclassified, wherever necessary, to make them comparable.
